A. Kitty Korner's accepts the Cat or Cats (collectively the "Cat") listed on the Guest Registration Form for boarding on the following terms and conditions:

1. Kitty Korner's agrees to board the Cat on the facilities situated at 1704 Fry Rd Nanaimo, BC V9X 1T2 (the "Kitty Kondo's") as shown on our web site www.kittykorners.com
2. Kitty Korner's will provide the Cat with the following:
 - a. Clean sanitary individual accommodation at the Cat Hotel;
 - b. Feeding schedule as directed by the Owners;
 - c. Clean Litter Box as needed (minimum 2x/day);
 - d. Daily care as directed by Owners;
 - e. Access to clean water at all times;
 - f. Regular supervision with use of the lounge;

B. Kitty Korner's has the following policies and the Owner(s) confirm that they have reviewed the following policies and agree to the terms and conditions set out below:

Reservations:

1. Subject to availability, Kitty Korner's Cats will reserve accommodation for the Cat upon receipt of a \$30.00 deposit. The deposit shall be non-refundable; Minimum stay is 2 nights. Reservations that include Christmas Day/New Years Day will be a minimum 4-night stay.

Delivery of Cat:

2. The Owner(s) agree:
 - a. To deliver the Cat to Kitty Korner's in a secure carrying case to be left on site;
 - b. Boarding shall commence on the date of the Reservation made by the Owner(s) whether or not the Cat has been delivered to Kitty Korner's Cats on the Reservation Date;
 - c. If the Cat is not delivered by 1:00 pm on the Reservation Date, the Deposit will be forfeited to Kitty Korner's Cats and the Reservation cancelled, unless alternate arrangements have been made;
 - d. By delivery of the Cat to the Kitty Korner's premises, the Owner(s) acknowledge that the premises and accommodations for the Cat have been inspected and found to be in a clean and sanitary condition and the Owner(s) acknowledge that they have satisfied themselves as to the safety of the facility and the condition of the premises in which the Cat will be housed and all other arrangements under which the Cat will be kept.

e. Drop off and pick up times will be done by appointment only between the hours of 9am – 5pm. Special arrangements must be made for Drop Off/Pick Up outside of regular hours and on Statutory Holidays. Additional charges will apply;

Condition of Cat:

3. The Owner(s) warrant and represent:

- a. Each Cat has been immunized within the past 12 months as stated in the Guest Registration Form; Owners must sign liability waiver for cats that are not current with their vaccinations
- b. To the best of my/our knowledge the Cat does not have fleas and has not exhibited any signs of fleas (such as continuous scratching or biting at itself); If fleas are found an advantage treatment will be given and the owner responsible for the costs incurred.
- c. To the best of my/our knowledge the Cat does not have any medical condition that has not been completely described in the Guest Registration Form;
- d. To the best of my/our knowledge using all reasonable due diligence, the Owner(s) confirm that the Cat does not harbor any disease that could be contagious either to other animals or to humans.

Boarding Rates:

- 4. a. **For overnight boarding:** A Day shall commence at the time of delivery of the Cat to Kitty Korner's premises and ends at 12:00 o'clock noon the following day.
- b. **Rate Schedule:** The Owner agrees to remit payment for the Boarding of the Cat in accordance with the current rates
- c. **Payment:** Payment of all monies outstanding shall be made to Kitty Korner's at the time the Cat is returned to the Owner(s) and shall be made by cash or cheque. Long-term stays will require a minimum 50% deposit on arrival. The Owner(s) agree to provide their credit card information to Kitty Korner's to be used in the event the Cat requires emergency medical attention as set out below

Emergency Medical Attention:

- 5. Kitty Korner's agrees that if, in the sole opinion of Kitty Korner's, the Cat requires medical attention, Kitty Korner's will attempt to contact the Veterinarian set out in the Guest Registration Form for consultation, either by phone or by delivering the cat to said Veterinarian for treatment at the Owner's expense;
- 6. In the event the Owner's Veterinarian is not available to Kitty Korner's, or is not situated within a reasonable distance of Kitty Korner's, Kitty Korner's, in its sole discretion, shall have the option of consulting with another qualified Veterinarian and, if deemed necessary, delivering the Cat to that Veterinarian for treatment at the Owner's expense.
- 7. Charges related to the emergency medical treatment of Cat (including mileage at \$.50 per mile and wages paid to the employee of Kitty Korner's delivering the Cat at \$20.00 per hour for the time spent for traveling and attending at the Veterinarian Office are for the account of the Owner(s).
- 8. Where possible, in the event of a medical emergency arising with respect to the Cat, Kitty Korner's will attempt to contact the Owner(s) or the local emergency contact to advise of the situation with the Cat.
- 9. The Owner(s) agrees to provide their veterinarian with an authorization letter event of a medical emergency, Kitty Korner's is hereby authorized to supply the credit card information of the Owner(s) to the Veterinarian caring for the Cat and the Owner(s) authorize such charges up to the sum set out in the Cat Particulars to be paid by the credit card.
- 10. Any Veterinarian expenses as a result of the above medical emergency that are paid for by Kitty Korner's on behalf of the Owner(s) shall be reimbursed to Kitty Korner's as soon as possible and prior to the return of the Cat to the Owner(s).
- 11. This contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Kitty Korner's.
